

# THE CORPORATION OF THE TOWNSHIP OF GEORGIAN BLUFFS

## BY-LAW NO. 23-2016

**BEING a By-law to adopt the estimates of all sums required for 2016.**

**WHEREAS** Section 290 of The Municipal Act, S.O. 2001, Chapter 25, provides that a local municipality shall in each year prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality including (a) amounts sufficient to pay all debts of the municipality falling due within the year; (b) amounts required to be raised for sinking funds or retirement funds; and (c) amounts required for any board, commission or other body;

**AND WHEREAS** Section 291 of the Act requires the Council of the Township of Georgian Bluffs to give notice before adopting all or part of a budget under Section 290, and such notice was given in accordance with the Act and By-law No. 1-2003 by being posted in on the Municipal Website on the 12<sup>th</sup> day of February, 2016 and March 8, 2016.

**AND WHEREAS** the Council of the Corporation of the Township of Georgian Bluffs has prepared such an estimate of all sums required during the year of 2016;

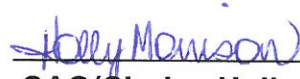
**NOW THEREFORE** the Council of the Corporation of the Township of Georgian Bluffs enacts as follows:

- 1) The estimate of all sums required for own purposes for the Township of Georgian Bluffs for the year 2016 is hereby adopted.
- 2) The estimate of all sums required for own purposes for the Township of Georgian Bluffs for the year 2016, also called the 2016 Budget, is attached hereto as Schedule "A" and forms part of this By-law.
- 3) This By-law shall come into force and take effect upon being passed by Council.

Read a first and second time this 16<sup>th</sup> day of March, 2016.

Read a third time and finally passed this 16<sup>th</sup> day of March, 2016.
