Summary

This report is a summary of water quality and quantity information submitted in accordance with Schedule 22 of Ontario's Drinking Water System Regulation for the reporting period of January 1, 2017 to December 31, 2017 for the Pottawatomi Drinking Water System (DWS) located in the Township of Georgian Bluffs. The summary includes the following information:

- Any requirements of the Act and Regulation, Orders or System Approval(s) that the system failed to meet during the reporting period and the measures taken to correct each failure.
- A summary of the quantities and flow rates of water supplied during the reporting period, including monthly averages and maximum daily flows.
- A comparison of the average and monthly maximum daily flows to the approved capacity specified in the System Approval.

Issues of Non-Compliance

An MOECC Drinking Water System Inspection was performed on May 2, 2017. On June 2, 2017 the report for this inspection was issued, the Pottawatomi DWS received an inspection rating of 100%.

The following is a summary of the requirements of the Act, the regulations, the system's approval, drinking water works permit, municipal drinking water license, and any orders applicable to the system that were not met at any time during the period covered by the report; as well as the duration of the failure and the measures that were taken to correct the failure:

- There were no non-compliances during the reporting period.

Assessment of Flowrates and Quantity of Water Supplied

The following table summarize the quantities of the water supplied during the period covered by the report, including monthly average and maximum daily flows as well as a comparison of the summary to the rated capacity and flow rates approved in the system's approval, drinking water works permit or municipal drinking water license.

As per Municipal Drinking Water License (MDWL) 083-101 (Issue Number: 2, expires August 22, 2021), the maximum daily volume of treated water that flows from the treatment subsystem to the Drinking Water System shall not exceed a rated capacity of 170 m³/day.
