What is proposed?

The subject property is currently zoned Agricultural (AG) under the Township's Zoning By-law 2020-020.

The applicant has submitted a Minor Zoning By-law Amendment request seeking the following relief:

- Section 5.1.1: Permit the construction of a garage (classified as an accessory structure) on the property without the requirement of a principal building.
- Section 5, Table 5.1: Increase maximum permitted lot coverage from 5% to 14.5%.
- Section 8, Table 8.2: Increase permitted lot coverage from 10% to 14.5%.

No other amendments to the Zoning By-law have been proposed at this time.



This application is being brought back to the January 21st, 2026, Council meeting as the applicant has submitted additional information related to the proposed minor zoning by-law amendment. The public meeting will provide an opportunity for continued discussion among stakeholders and members of the public and will assist staff in receiving further direction on the matter. 
